#### DESCRIPTION OF DEPOSIT/DESCRIPTION DU GISEMENT

A quartz vein occupies a fault along the north wall of a quartz porphyry dyke about 15' wide. The dyke cuts a diorite boss of Coast Intrusives that intrude Jurassic Hazelton Group volcanic breccia. The vein strikes S60°E. dips steeply south, and has an apparent length in excess of 1,000'. It ranges from 2' to 10' in width and contains a sparse dissemination of pyrite, chalcopyrite and galena throughout and several short, rich ore shoots. One such shoot, about 1' wide and 25' long, contains galena, sphalerite and tetrahedrite, cut by narrow chalcopyrite veinlets. A channel sample across this shoot assayed: Gold, 0.16 oz/t; silver, 92.0 oz/t; zinc, 17.28%; lead, 6.10%; copper, 1.42%. A 36" channel sample across a sparsely mineralized part of the vein assayed: Gold. trace; silver, 1.80 oz/t. Gold assays as high as 1.21 oz/t have been reported. Locally the quartz contains scheelite.

### HISTORY OF EXPLORATION AND DEVELOPMENT HISTORIQUE DE L'EXPLORATION ET DE LA MISE EN VALEUR

The showings are located at 4,000' elevation in the east wall of a circue at the head of the south fork of Legate Creek, some 21 miles northeast of Terrace.

The property, owned by W.L. Jordan and J.R. Smith, was held as the White Bear and South Fork claims in 1925 and as the Zona May group in 1926-28.

Carl Creek Gold Mining Ltd in February 1981 optioned the Tom and Tom 1 claims (21 units) covering the Zona May showings from T.M. Conway, of Vancouver. In June 1981 the company entered a joint venture agreement with Claude Resources Inc to explore the property. The company name (Carl Creek Gold) was changed in August 1981 to Carl Creek Resources Ltd.
