This property is located on the northwest shore of Ealue Lake, some 50 miles east-southeast of Telegraph Creek.

The showings were discovered by Joe Williams of Telegraph Creek late in 1929 and 8 claims were staked. In 1931 the Klapan group of 10 claims was owned by J.G. Hope & associates of Telegraph Creek. Development work consisted of stripping, several open cuts, and an adit 21 feet long. The showings were further prospected during the 1932 field season.

The MFJ 1-4 and MFJ Fraction No. 1 claims were acquired by Yukonadian Mineral Explorations Limited in about 1969. An additional 26 claims were staked by the company. Granduc Mines, Limited optioned the property and in 1970 carried out geological mapping, and a geochemical soil and stream sediment survey.
